The government's Finance Department, Sales Tax Administration-1, Ministry, Mumbai - 400 032 is advised to implement it.
2. The original certificates you submitted will be assigned to the subject post prior to appointment, based on the examination results that support your claims. Suggestions ought to be made contingent on Prasana-level testing, eligibility of the suggested candidate, observational qualification, age restriction, NCL, and social and parallel reservation in addition to disability claims pertaining to your original certificate, as confirmed by the government's registered/competent officers. It is recommended that candidates who do not pass the current examination verify their original certificates at the Prasana level before making an appointment according to the schedule. Only if the nominated applicant meets the requirements for eligibility, education, quota, and NCL will you be assigned to the relevant role.
3. The announcement is subject to the final verdict in various original appeals/petitions filed in the Maharashtra Administrative Tribunal and Hon'ble High Court.
4. As per the recommendation made in the notification at the Prasa level, the applicant is recommended to the Prasana in accordance with the claim mentioned in the current examination, subject to the condition of verifying the eligibility from the original certificate. If the information provided in the application form is found to be false or fraudulent, or if the required certificate is not fulfilled as per the claim in the application form, your candidature will be cancelled at any point.
5. It is extremely serious to make incorrect or misleading representations. In this context, you should pay particular attention to the candidate's general instructions and the affidavit you provided for the relevant exam.
6. The written sample must be posted on the Commission's website, <https://ampec.gov.in>. The aforementioned attestation form needs to be downloaded, completed, and sent right away to the relevant department or mutual appointment function. It should be noted that if the relevant column is crossed off or left blank, the specimen will not be accepted.




